**Please note confirmations of entry will be emailed. We will try our best to send confirmation of entry within 48-72 hours (excluding weekends and February 1-9).**

Approximate judges briefing times and arrival times for levels starting later in the day will be emailed out to entrants closer to the trial date (approx. a few days prior) but we ask that you please keep in mind all times are approximate. Limited indoor crating will be available if dogs can be kept quiet.

**Entry:** In order for your entry to be processed we must receive both the payment and entry. If your name is different than that of the entry for your payment or you are paying for multiple dogs/persons please indicate this in the memo field of the e-transfer. Please note confirmations of entry will be emailed as soon as possible once received. Please note that we may take 48-72 hours after receiving your entry to process and send you confirmation (excluding weekends and holidays). Please note that entries will not be processed Saturday February 1<sup>st</sup> thru Sunday February 9<sup>th</sup> due to holidays.

**Payment:**

- PayPal - All PayPal payments must be sent in Canadian dollars and are subject to an additional \$10 fee per transaction fee. Please send payment to [quintecanine@hotmail.com](mailto:quintecanine@hotmail.com)

**Closing Date:** Day of trial or automatically when time limit has been reached. On site entries accepted *if* space is available.

**Refunds for Medical Reasons:** entry fee refunds will be given for any dog withdrawing for medical reasons. A Veterinary Certificate must be submitted before the start of the trial.

**FEO:** General public entries will be accepted prior to FEO (if the trial fills, regular runs will take priority)

**Move Ups:** If a move up is needed prior to the trial please email us as soon as possible to ensure scheduling can be completed efficiently. Move ups will be permitted on trial day, please advise the secretary as soon as possible.

**Awards:** Qualifying ribbons and Title Rosettes are available for regular titles. Please let the trial secretary know as soon as possible after your run if your run provided you a title so rosettes can be prepared. Please also complete the Titles Earned sheet which will be made available in a common area on trial day.

**Location Information:** Limited indoor crating is available for dogs who can be kept quiet, please come prepared to crate from your vehicle if it is full. No shade is available on site. Tenting is permitted if it can be properly secured to your vehicle in case of winds.

**Barking:** We are situated very close to a residential area so we must do our best to keep barking to a minimum at all times when in the parking lot. Ongoing excessive barking on the property or within vehicles is not permitted.

**Flooring & Shoes:** Our main trial space is vulcanized rubber. Please do not forget indoor shoes that are quick and simple to slip on – no outdoor shoes are allowed in the main training area.

**Food:** There will be no food available on site. (A few restaurants are within a few minutes drive).

**Photo/Video:** By submitting entry, the client agrees to release photo and video to the ownership of Quinte Canine for promotional or educational purposes.

**Equipment:** Absolutely no prong collars, slip leads, choke chains, shock collars or retractable leashes are allowed on the trial grounds at anytime.

**GENERAL INFORMATION:** This is a Canadian Association of Rally Obedience (CARO) sanctioned trial that will be held under CARO rules and regulations. Through submission of their entry, the Competitor acknowledges that they have read and understand the CARO rules and regulations. All dogs must have a CARO registration number in order to compete. This registration should be applied for in advance of the trial, or you may do so at the trial by bringing the completed form, and a cheque for the correct amount (payable to CARO).

It is expressly understood that exhibitors alone are responsible for the behaviour of their dogs and/or persons attending with them. Any exhibitor whose dogs and/or persons attending with them (including children) create unnecessary disturbances or engages in unsafe, disruptive, or aggressive behaviour may be asked to leave the grounds; no refunds will be given.

An officiating Judge, and/or the Chairperson of the trial, may dismiss from the trial site any person subjecting the Judge, members, volunteer, or the organizing committee to abuse, whether that person is competing in the trial or not.

Please note that due to insurance reasons, handlers must be over the age of 10 on the date of the trial to participate. All handlers aged 10 to 16 must have a legal guardian present at all times. If the handler is younger than 16 years old, please have the legal guardian complete this form as well as email [quintecanine@hotmail.com](mailto:quintecanine@hotmail.com) immediately to advise.

By submitting entry, the handler is confirming that the dog is up to date on the Distemper, Hepatitis, Parvo and Rabies vaccination on the date of the trial. Handlers may be asked to provide proof of this at anytime leading up to the trial. If an entrant is not current with these vaccinations and is asked to provide proof, they have until trial date to bring their vaccinations current or they forfeit their entry and all associated fees. Quinte Canine will accept Titre test results with veterinary letter in lieu of vaccinations.

**Private Property:** Please potty your dog only to the east of our building (between the building and brush) as all property to the west of our building (the neighbourhoods) is private property. If you need to walk your dog prior to the trial after a long car ride, just email us for some suggestion on local public areas that you can go. Please see map on below and do not allow your dogs onto or beyond the red areas.
